# MINUTES OF THE REGULAR MEETING OF THE BOARD & MEETING OF THE MUNICIPAL ZONING BOARD Wednesday Ortobay (4) 2021

Wednesday, October 6th, 2021

The Village Board of Trustees held an open forum meeting prior to the Regular Board Meeting allowing the public to voice their opinions regarding cannabis retail dispensaries, onsite consumption, and the Opt-Out Law choices. There were ten residents/property owners and one non-resident in attendance, of which eight were in favor and three were opposed. It was decided that the Village Board would conduct a non-binding survey which would be sent out with the October Water & Sewer bills to all stakeholders, regardless of residency. These must be returned to the Village Office by Monday, November 1<sup>st</sup> at Noon. Another Open Forum Discussion is scheduled for the next Board Meeting on November 3<sup>rd</sup>, at 5:30 at the Village Office.

Following the Open Forum Discussion, Mayor Meeder called the meeting to order at 6:35pm and led everyone in the Pledge of Allegiance. Board members Colleen Meeder, Ryan Sanders, Donna Higginbotham, Kirk Ayers and Dennis Watson, Clerk-Treasurer Jeanette Ramm, Chief Operator Jay Irwin, Gary Emory, Marty Proctor, and the press were in attendance.

# **REGULAR BOARD MEETING:**

The mayor reported how Mr. Gormley is already addressing concerns as the Fair Housing Officer. An issue arose which was unclear as to which department it fell under: water & sewer, fire

department, code enforcement, etc. But this ended up being a Fair Housing concern, and he is working with this resident at the North Haven Apartments.

#### DEPARTMENTAL REPORTS FROM CHIEF OPERATOR

- **SEWER** Chief Operator, James Irwin and retired Chief Operator, Paul Fisher, are being presented with the WEFTEC Ingenuity Award for their innovative "Sludge Ski Rig". Mr. Irwin will be away for two days to attend the ceremony in Chicago where he will give a presentation explaining how the rig works.
  - The WWTP pre-bid meeting is scheduled for November 7<sup>th</sup> and the meeting to open the bids is set for November 25<sup>th</sup> at 2pm.
- WATER First and Edmunds streets are complete. All the service lines have been connected to the main water line, and the black top and hydroseeding will be complete by the end of the week and Northrup will finish reclaiming next week.
  - While connecting the mains to the service line at 147 Kipp Street it required a push (additional 3ft x 3ft hole to accept the pipe) and their rhododendron bush was damaged by the loader. We have photos and will get pricing to replace what plants were damaged. Nina Coyle would like something in writing.
- STREETS The trackless 'sidewalk plow' has come in and is ready for the winter season.

## **GRANT APPLICATION UPDATES**

**Status of Grant Funding Applications (non-CFA):** 

**DEC ZEV** (**Zero-Emission Vehicles**) - Electric Vehicle Charging Stations – the NYSDEC awarded the Village a rebate of \$217,200. This is a reimbursable grant as explained in the motion.

**RBDG** – **Rural Business Development Grant**, for signs is still outstanding, still in process, not yet awarded.

## **CAPITAL PROJECT UPDATES**

#### **COMPREHENSIVE PLAN**

- We are submitting final reports and nearing the completion of **NYSDEC Climate Smart** Communities Grant.
- NYMS-TA (New York Main Street Technical Assistance) Grant Clinton Brown Company Architecture (CBCA) will begin the building surveys in October. They will study 4-5 buildings, both the interior and exterior of the buildings, and have already met with the Steering Committee. CBCA plan to wrap their study up in March so that we can meet the July application deadline to the CFA for the implementation phase which is \$300K-\$400K. Even buildings that are not included in the study phase, can be included in the implementation phase. The implementation grant allows up to \$50,000 per building, plus an additional \$25,000 per residential apartment in grant funding. We may focus the \$300K-\$400K on our Main Street façade this time and reapply for the apartments and internal repairs on the next application, but this will be determined as part of the study. Some of these aspects may be included in our Downtown Analysis Study as we try bringing more business into Sherman. Mayor Meeder restated that this is a reimbursable grant and was happy to report that we got a lot of applicants.

• **CDBG-Community Planning** - RFP is out for the Downtown Market Analysis which is due October 18<sup>th</sup>.

#### **SEWER**

• The bids for the wastewater treatment projects (construction, mechanical and electric) are due October 25<sup>th</sup> and will be opened at the meeting in the Village Office at 2pm.

#### WATER

• Northrup will finish the reclamation, hydroseeding, and the sidewalks, and then they will start on the Water Pump Houses.

#### **STORMWATER**

- USDA RD we are working on the requirements listed in the Letter of Conditions for the \$3.5M commitment by USDA-RD for the long-term debt portion of the Stormwater project. We were not awarded the 2020 GIGP and had to reapply, so our project has not started, delaying our completion of the requirements listed in the letter of conditions. USDA-RD understand this, and we will revisit this in the beginning of 2022 once we know whether we are awarded the 2021 GIGP.
- We have officially closed on Firster Property and are awaiting closure of Nature Center property.

## **COMMITTEE UPDATES**

## Tree "Beautification" Committee

- The committee met and decided to focus on Osborne and Franklin Streets, along Route 76. The Ivory Silk Japanese Lilac is salt tolerant, low in height (for electric lines) and accommodates smaller spaces i.e., between the road and sidewalk.
- There are a few Sunset Maple trees on order as well.

#### **Planning Board**

- The board met with Stephen LeFevre of Barton & Loguidice on Monday, October 4<sup>th</sup>, to review the status of the Solar SEQRA.
- They received updates, reviewed the current projects and discussed the Cannabis law(s).

## **Steering Committee**

- The committee met Alma Brown of Clinton Brown Company Architecture on Monday, October 4<sup>th</sup>, and reviewed the building applications, prioritizing the selection for the Village Board of Trustees
- At their next meeting they will begin discussions on Zoning Law amendment priorities, particularly Cannabis, and other details such as fences, etc. The cannabis focus not only concerns the Opt-Out law, but general zoning regarding smoking near schools, churches, and in public parks, and proximity to public doors and venues, and other issues related to the legalization of cannabis.

#### MAYORAL ADDRESS

- Halloween trick or treat hours were discussed.
- Clerk Ramm is working with the Chautauqua County's Visitor Bureau and local businesses to ensure that the 2022 Chautauqua County Travel Guide features a Sherman page.

- Triple E Manufacturing is growing and looking at extending their current building or moving into bigger premises. They have been in discussion with their neighbors and with Village employees to determine boundary lines and stormwater issues. They are a great business to have in the Village and we are working with them to find the best course of action.
- Trial Town we are trying to establish a trail between Clymer and Sherman to fill in the gap and complete the trail from Pittsburgh to Erie. In support of this goal, Patrick Johnson just held a bike ride from the trail head in Sherman which ended at the Dutch Village in Clymer on October 2<sup>nd</sup>. The trail from Pittsburgh comes all the way up through Corry and into Clymer, and our desire is to extend the trail to connect to the Sherman trail.

In accordance with the Letter of Conditions signed with USDA RD (Rural Development), the insurance on scheduled employees of \$200,000 was increased to \$300,000 for the purpose of covering the total cumulative value of all 'potential' USDA RD annual estimated principal payments in the amounts of \$12,000 for Street Equipment, \$152,000 for WWTP, \$116,000 for Stormwater = \$280,000.

#### RES 2021-10-06.4: INSURANCE OF SCHEDULED EMPLOYEES

DEC-ZEV (Zero Emission Vehicles) Charging Stations – \$217,200 is one part of a two-part rebate program with NYSDEC and National Grid. This is a 'reimbursable' grant, where the items must be paid for and then the NYSDEC reimburses the Village of Sherman.

#### RES 2021-10-06.6: NYSDEC GRANT / REBATE FOR EV CHARGING STATIONS

Motion to accept the awarded rebate of \$217,200 for the application DEC01-ZEVIN-2021-00016 through Round 5 of the Municipal Zero-Emission Vehicle (ZEV) Infrastructure Grant Program.
