# MINUTES OF THE Brief SPECIAL BOARD MEETING Thursday, August 28, 2025, at 6:00am

Mayor Meeder called the special meeting to order at 6:00am and lead everyone in the Pledge of Allegiance. Board members Colleen Meeder, Ryan Sanders, Dennis Watson, Gary Emory and Danielle Crane were in attendance.

## **Comprehensive Stormwater Improvement Project**

"Upper Basins"

The Village is working with Chautauqua County Soil and Water Conservation District who will be taking on this project involving two distinct sites. First, the installation of a dry detention pond, NW of the Nature Center Pond, situated along the creek slowing the vast amount of water from Drainage Area 3 prior to flooding residents and the athletic field (that has served as the de facto stormwater detention area prior to receding to French Creek). Second, installing a flood bench, i.e. expanding and regrading an area to temporarily detain flooding from Drainage Area 2 along the North Haven/Sherman Apartments, which flows to west Park St, between Kipp and Church Streets to W Main St, before crossing under Edmunds Park to French Creek.

Additionally, directional drilling will be involved in conveying stormwater from upper Miller St. to the dry detention pond at the Nature Center. In attempts to capture flooding in Drainage Area 3, beginning in the Town of Westfield at Titus Rd, that flows behind the west side of Columbia St.

The following resolution temporarily decreases some administrative budgeted amounts to be allocated for the Upper Basins; until the over/under <u>credit</u> with Legend Excavating of \$138,780 is restored at the end of the Main St phase of the stormwater project is complete and the contract with Legend Excavating is closed.

### RES 2025-08-28.1: STORMWATER BUDGET (w/ RD Revision) FORM E #8

At a Meeting of the Village of Sherman, Chautauqua County, New York, held at the Village Hall, in Sherman, New York, on the 28<sup>th</sup> day of August, 2025, at 6:00 a.m., the following resolution was offered by Trustee Emory who moved its adoption, seconded by Trustee Watson to-wit:

**RESOLUTION OF THE VILLAGE BOARD**, VILLAGE OF SHERMAN, CHAUTAUQUA COUNTY, NEW YORK, accepting Revisions to the "Village of Sherman Stormwater Infrastructure Improvements Project", Capital Project as administered through USDA Rural Development. The Village Board hereby modifies the following Administrative and Construction budget items to the upcoming Form E #8:

- **A.1** Local Legal to be decreased by \$4,751.64
- **A.3** Net Interest to be decreased by \$10,000.00
- **A.7** Single Audit to be decreased by \$29,123.20 (\$43,874.84)

C.2a Upper Basin Construction to be increased by \$43,874.84

Revision requested by RD: moving \$310,000 for Upper Basins from "Direct Expenditures" to "Construction Contracts"- with no effect to the budget or intent of the Village Board of Trustees RES 2025-08-28.1 in allocating budget funds for the CCSWCD contract for the construction of the Upper Basins:

<u>C.2a</u> Upper Basin Construction to be decreased by \$310,000

**C.1b** Upper Basin Construction to be increased by \$310,000

The reason for these modifications is to update the allocation of administrative costs and the direct expenditure construction costs of the Upper Basins (Phase 2) Stormwater Improvements for the installation of the flood bench near the Sherman Apartments off Church St in Drainage Area 1, and with directional drilling, capture and convey stormwater from upper Miller St to the dry pond to be constructed near the Nature Center for stormwater detention in Drainage Area 3; and therefore allowing the Village of Sherman to enter into agreement with Chautauqua County Soil & Water Conservation District to construct the aformentioned stormwater management design and to subcontract the directional drilling services for the Upper Basins project.

THIS BUDGETARY MODIFICATION RESULTED IN NO CHANGE TO THE TOTAL BUDGET.
